Action 114: Keswick Archers have obtained a quote from a local company, of approximately £4,400. This includes: erecting a "tent" inside, behind the shooting line, and the inside of the tent will be heated; and installing cage outside for the gas bottles. Keswick Archers can pay £1000. A grant application is being made to the local Council. Archery GB wouldn't help because they need a minimum of a 15-year lease, but the owner can only agree to a 5-year lease. Keswick Archers are looking for other funding from organisations such as the Lions, and Rotary Clubs. Those at the meeting also suggested trying the Cumbria Foundation; GDF; United Utilities, and local Banks. It was agreed that the County would give £1,500, which equated to the saving of not using the Penrith Leisure Centre. It was also agreed that the County would make-up any shortfall in funding if the other organisations mentioned previously, didn't cover the remainder (approx. £1,900).
