Officers Reports -

Chair - Simon Degler

Recently this year Alf Davies died after a long illness. Alf had a huge influence and impact on archery in the UK, but not as an archer! In fact Alf was not a very good archer himself, however he had an ability to spot and nurture talent. The likes of Darren Phizaklea, Alan Wills and Jon Shales (to name but a few) would not have achieved what they have without his influence. Alf was President of GNAS and he delivered the World Junior Archery Championships at Lilleshall. He will be sadly missed.

Last year we had a disciplinary incident which was raised up to County level. For the record I did try to hold a meeting with both Cockermouth Company of Archers and the two people involved with the disciplinary, however this met with a refusal from Cockermouth. I was therefore unable to bring the matter to a satisfactory conclusion for all parties concerned, and now the whole issue has been raised with Archery GB. This is something which I had desperately tried to avoid. In case you're not aware Archery GB spends tens of thousands of pounds on dealing with internal Club squabbles. This money could be better spent on furthering archery in the Country, like funding additional archers to international shoots, coaching grants, or anything more productive than arbitrating squabbles. We do this sport for the love of Archery. Let's not lose sight of that, and try to sort out any disagreements between us rather than waste our Archery GB subs which could be better spent elsewhere.

Congratulations to Alan Wills who is ranked No2 in the UK this year and won the Grand Prix Finals, despite a total lack of funding. Well Done Alan. We asked Clubs to offer Alan some support towards his expenses now that he has lost all his Lottery Funding. I must say that I am a little disappointed that only two clubs offered any support. Considering that Alan is an ambassador for the sport and has supported County events and helped many archers throughout the County, I feel that for only two Clubs to offer support was a little mean. Despite this Alan was extremely grateful for that assistance.

I'd like to give thanks to the committee members who have worked tirelessly over the last year. Paul has managed to create a new lease of enthusiasm in the County Squad and has managed to pull together a new team strip. I have been on the County Team now for 20 years and I can honestly say that this is the first year that we've actually looked like a team. All we need now are the results to go with the strip, which I'm sure will come.

We have run a Level1 coaching course and are currently running a Level 2 course, and we even ran a session for existing coaches to help share tips and pointers.

I tried to arrange a session with Duncan Busby for Compound archers, however the dates he had available at the time all clashed with existing County events. I'll try again over the next year.

I'd like to thank Jim for his sterling efforts around the County which have resulted in the formation of two new clubs within the County. This is bringing the sport into new catchment areas and also will help bring more funds into the County coffers. Tim is looking to step down as County Treasurer after many years in the post. Under his tenure County funds have increased steadily (due to his careful financial management) which now allows us to offer assisted travel to Inter-County events, assist County members in coaching course expenses. Tim will leave the role with the County in a very healthy position.

Last, but not least I'd like to thank Chris for his efforts as Tournament Organiser. He really is Mr Nike! He just gets on and does it, and does it very well. For those who don't know Chris was nominated for an award for services to archery at the Archery GB AGM. Unfortunately he was piped to the award by Jon Nott who runs the Grand Prix series.

To close then, despite not having a great year with respect to Inter-County results, I feel that we have made progress and created a level of momentum not seen for a long time. I hope that we can continue with that momentum and move forward in the future.

Having decided not to put the fees up and with some of the expenditure that we knew was going to carry over from last year we have just made a profit last year. We also spent a considerable amount of money on subsidising the new county shooting kit albeit, most selected archers then spend far more of their own bringing it up to a full set of shooting cloths.

Coaching has been a net drain on the County's funds again but we have subsidise two courses this year and both the L1 and L2 courses were well subscribed and have produced a number of good coaches for the County. In fact in terms of coaches per members we are very well provided for against most other counties. We are looking to run another L1 course in the spring and possibly a further L2 course although I am not sure that this will be very heavily subscribed from within the County and in that event we may want to consider a lower subsidy and work closer to a figure of £75 per Cumbrian participant. We already have a twin pricing structure to ensure that the County does not subsidise other counties' archers so we are just reflecting existing practice. It would then help coaches travelling out the county to attend courses.

Membership Fee income has increased again. This reflects the growth seen in the sport post 2012 although the challenge will be to keep them at renewal. Early indications are this is not going to be a problem and I do not detect any falling off in demand for beginners courses. I would say though that most clubs are awash with

novice archers which bring its own challenges – not least getting them to go to competitions.

Shoot income is up again and once more thanks to Chris for his efforts. Expenditure has also gone up as we have replaced our medal stock.

Sorry I cannot be with you to answer questions but as ever I am tied up with National business and have too much to do around the specification of the new L3. However please e-mail me any questions on tim.swane@btopenworld.com

Once again I am keen to step aside if there is another willing volunteer but anticipate nobody will come forward. I do retire in 4 years and at the moment my plan is to move back to Suffolk to be near Anna so you have another 4 years to find a replacement. Assuming nobody comes forward I will carry on for another year.

Matters arising from Treasurers Report

Freya asked a question about the Archers Shoot Expenses. There is £1180 in the left hand column, for 2012(?), and only £160 in the right hand column for 2013(?). Why is that?

As most of you will be aware this has been a busy year for me and the County as far as tournaments are required. Not only have I had a tournament to organise nearly every month but sometimes twice a month and then some tournaments have been for two days.

It has been encouraging seeing some new faces from the county at the shoots and I hope that continues as we still rely heavily on non Cumbrians to swell the numbers and make them viable.

Unfortunately we are still suffering from people booking places by word of mouth, email and telephone and then not turning up thus causing the income from the shoots

being lower than it should be and also preventing others from shooting as with the indoor shoots where there is a limit to how many targets I can fit into the sports hall. With this in mind and with the approval of the committee I intend for next year's tournaments only to accept entries with the fees included so no fee no entry. This seems a bit harsh but in reality it is the correct way to do things as the venues costs keep going up and I try to keep the fees reasonable, for example today this shoot needed at least 26 entries just to pay for the hall.

Cheshire Archery expressed a wish for someone to run the NCAS INDOOR CHAMPIONSHIPS next year as they would not be able to get a venue so I have decided to do it for them which will bring another record status competition to Cumbria.

After all this moaning in general the competitions have gone well and a reasonable profit has been made for the Counties coffers and I would like to thank all the new helpers who have given their time to help my small team get the equipment to and fro from storage to venue to storage. This has made it easier and less time consuming and means I get to bed earlier after making final checks that I have done everything.

It was raised by Simon, that the role of Chairman, Secretary and Treasurer were now all held by people from the Sellafield club, and he asked if there were any objections to this. No one objected.

Alf Davies Memorial Award

It was suggested that there should be some sort of Award, based on Alf's support of Juniors. This could be a Trophy which would be awarded on a yearly basis. Perhaps a glass trophy, if there were some money for it from the County Treasurer.

This could be at a Memorial Shoot, perhaps this could be an existing shoot - renamed; the Head-to-head, for example. The trophy would be awarded at that shoot. Nominations would need to be received prior to that. The County Secretary would contact Club Secretaries 6 months before the shoot to remind them about the award. Then the County Secretary would contact Club Secretaries 4 months before the shoot to ask for their nominations within two months. The County Committee would review the nominations and decide who it would go to, and have the trophy engraved. The Clubs would nominate someone:

- who work with Juniors
- a Junior who has an outstanding achievement
- who works in the background
- is an ambassador for juniors

The nomination would be around 100 words to say why the club thought that person deserved the award.

The recipient would also receive a medal, which they would keep.

Item 1

Craig has been looking into purchasing a Chain of Office for the Honorary President. He has found one company which can supply this for approximately £400, and Year-bars would be extra. There is one other company, that will do whatever you want, but won't give a price until the design has been agreed. The impression is that this would cost considerably more. They will do whatever you want, if you have the money!

Craig asked if the committee wanted a Chain of Office, and it was agreed that we did. Action - Craig will circulate the web-link for the first supplier.

Chris said he would ask the existing supplier of medals, too.

This would be discussed further at the next committee meeting.

Item 2

Lorraine asked if a Non-shooting member should pay a membership fee. It was agreed that they should. This would give the County some additional income.

Item 3

Stuart circulated copies of the updated Constitution. These were voted on, and were unanimously accepted.

It was agreed that non-shooting members would pay the same county fee as a Junior, or a Senior; as appropriate.

The fee was discussed. It was agreed that the fee wouldn't be reduced on a pro-rata basis, the full fee would apply whenever an archer joined throughout the year.

The accepted version of the Constitution is to be sent to all Committee members and Club Secretaries.

Item 4

Stuart attended the meeting in Newcastle-upon-Tyne, set-up by the Board of ArcheryGB to discuss the proposed future make-up of the Board. There is a presentation summarising the outcome which is available on the ArcheryGB web-site. The main proposal is to include "independent" board members from outside archery, to bring their skills and experience. There is also a questionnaire on the web-site to give everyone a chance to comment.

Item 5

Summary of NCAS meeting on 23rd November.

- The Disciplinary Policy/Procedure has been written by ArcheryGB and is being put into the approved "style".
- It was proposed to keep a register of grounds which have been inspected by a judge. Ground should be re-inspected if there has been a change.
- It was proposed to put a rider on shoot entry forms: if an archers behaviour is unacceptable, they will be removed from the shoot, by a Judge or the tournament Organiser. This will also be recorded on the Record Feedback Form for Record Status shoots.
- The latest version of "Flightpath" the newsletter for Flight shoots is available from the County Secretary. The venue for the 2014 shoots has changed.
- The minutes of the latest EAF meeting and AGM are available from the County Secretary.
